Resolution No.1.

The basic remuneration of Lecturers in Management Post is fixed to **Rs.30,000/-** per month w.e.f 01.04.2022.

Resolution No.2.


The basic remuneration of Clerical Staffs / DEOs in Management Post is fixed to **Rs.15,000/-** per month w.e.f 01.04.2022. However, staff who are drawing more than **Rs.15,000/-** per month are allowed to continue in their present amount which they are drawing.

Resolution No.3.

The basic remuneration of IV grade employees in Management post is fixed to **Rs.12,000/-** w.e.f 01.04.2022 provided that their service is more than 10 years. However, the IV grade employees getting more than **Rs12,000/-** per month are allowed to continue in the present amount which they are drawing.
